## INVITATION TO BID FOR [Supply and Delivery of 1 unit Motor Vehicle (Pick-up Truck)]

- The [Local Government Unit of Magalang, Pampanga], through the [portion of the 20% generated from collection of fire code fees
  and other charges under the Fire Code of the Philippines] intends to apply the sum of [Php 1,291,623.55] being the ABC to
  payments under the contract for [1 unit Motor Vehicle (Pick-up Truck)/ PG 2024-03-002]. Bids received in excess of the ABC shall
  be automatically rejected at bid opening.
- 2. The [Local Government Unit of Magalang, Pampanga] now invites bids for the above Procurement Project. Delivery of the Goods is required by [30 c.d.]. Bidders should have completed, within [2 years period] from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified
  in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
  - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The Procuring Entity shall allow the bidder to present its proof of payment for the fees [it will be presented in person].
- The [Local Government Unit of Magalang, Pampanga] will hold a Pre-Bid Conference on [April 4, 2024 (10:00 A.M.)] at MBO Conference Room, 2<sup>nd</sup> Flr. Claro M. Recto Multi-Purpose Building, Municipal Compound, which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat through [manual submission at the office address indicated below, on or before [9:00 A.M., April 16, 2024]. Late bids shall not be accepted.
