Proposed Desilting/Maintenance of Quitangil River along San Miguel-San Agustin Section, Magalang,

1. The Local Government Unit of Magalang, Pampanga, through the [FY 2024 Local Budget/20% Dev't Fund] intends to apply the sum of [Php 3,000,000.00] being the Approved Budget for the Contract (ABC) to payments under the contract for [Desilting/Maintenance of Quitangil River along San Miguel-San Agustin Section and Project Identification Number PI 2024-03-001]. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Local Government Unit of Magalang, Pampanga now invites bids for the above Procurement Project. Completion of the Works is required [50 c.d.j]. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
